

HOW TO LIST YOUR PRODUCTS IN BIOVIA® ACD OR BIOVIA® SCD

WHY PARTICIPATE

The BIOVIA Available Chemicals Directory (BIOVIA ACD) is the industry-leading structure searchable consolidated collection of commercially available chemicals from across the globe. BIOVIA ACD is trusted and used by more scientists than any other supplier database worldwide and has been the de facto standard in pharmaceutical, biotechnology, chemical and agrochemical companies worldwide for over 25 years.

The BIOVIA Screening Compounds Directory (BIOVIA SCD) complements BIOVIA ACD with almost 10 million screening compounds, making it one of the most comprehensive high throughput screening collections available today.

If you are not sure which database is appropriate for your product listing, please contact us at List_custom_BIOVIA_ACDSuppliers@3ds.com and BIOVIA will review all the submitted information and determine to which database your catalog will be included. **Please also request a Supplier Certification Agreement, which must be signed and returned in order to include your company in BIOVIA ACD or BIOVIA SCD.**

REQUIREMENTS

We must receive supplier product data electronically.

Preferred electronic formats are:

- BIOVIA ISIS/Base local database
- BIOVIA SDfile
- BIOVIA RDfile
- Microsoft® Excel® spreadsheet
- Microsoft® Access® database
- Oracle® tables (as Oracle export file)
- Delimited ASCII text files

When submitting electronic data, please send a complete representation of your product data (i.e. the same data you would provide in a printed catalog)

The minimum information we require for every product is a catalog number, chemical name and/or structure (in MDL molecule file format), and availability data for each product. We do ask however that you send as much information as possible for each of your products. For example:

- Product name
- Catalog number (SKU if available)
- Structure
- Synonyms

- CAS Registry Number
- Package quantity | Package units | Price
- GHS data for relevant products
- SDS url links to website, if available
- Purity
- Specification | Grade
- Hazard, Risk and Safety data
- Chemical/Physical properties (including units), such as Melting Point, Boiling Point, Density, Refractive Index, Optical Rotation, Isotopic Enrichment, LogP
- Other relevant data associated with the compound

This data should be stored in separate fields, in one of the preferred electronic formats.

Please provide your complete company contact information, as you would like it to appear in the database. Include global distributors if you have them, along with their address, phone/fax, email address and URL. You must have a working website before your product list will be included in ACD.

We will also need your direct contact information for future communications so that we can keep your product listing up-to-date and provide feedback on data related issues.

TIPS FOR SUBMITTING SUPPLIER DATA:

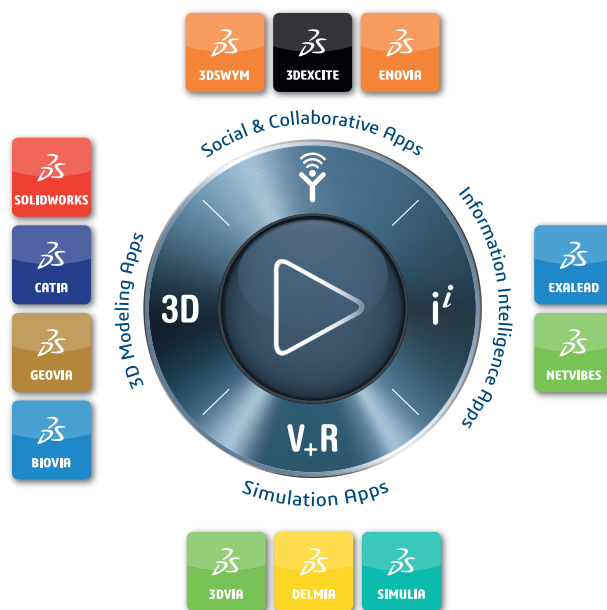
1. We prefer that you provide full product updates for each submission to BIOVIA ACD. However, if you do provide supplemental product updates, please clearly indicate which products have been dropped and/or revised.
2. Please include persistent catalog number identifiers for all your products. If you have package-specific catalog numbers, these are preferred. If you cannot provide catalog numbers, or if you reassign catalog numbers, this may result in a processing delay or may limit the number of products we can include in the database.
3. All data fields should contain just one type of data, e.g., don't include purity data in the product name field.
4. Please make sure that your quantity, unit and price data are in a consistent format. This data must be in separate fields rather than combined in one field.
5. Please bear in mind that clean and accurate data is critical to ensure that it appears in the latest release.
